1. Minutes of AGM in Romania 2017- matters arising

Minutes from General Assembly meeting from Romania in 2017were circulated before meeting – no issues were raised form the minutes of the meeting.

2. Proposed Changes to the constitution.

Details of following changes to constitution were circulated to all members with notice of the meeting. Eckart gave further detail and explained the rationale for the propose changes and invited comment.

- Article 1: aim "with a focus on Europe" / headquarter France (Molsheim)
- Article 2: admittance more precise definition, associated members
- Article 3: annual subscription for full members, depending of ind.members
- Article 4: General Assembly, Board of Directors, Executive Board virtual f.
- Article 5: General Assembly NO election of the Board of directors (3 years)
- Article 6: Board of Directors election of the executive board (p, 2vp, tr, sec)
- Article 7: Executive Board (3 years period), administrator, 6 additional appointed m.
- No changes Article 8, 9, 10 numbers of articles changed.

(Note – An electronic vote procedure was enabled through ZOOM. Only Presidents of the 19 national organisations present were entitled to vote at the meeting)

The proposed changes were passed by a vote 19 for -0 against. Anne Hürzeler - de Turckheim to notify court in Molsheim in France of the changes to the constitution.

3. Report of the President

Eckart outlined his participation in meetings and conferences on behalf of Pro Silva since the previous meeting. Eckart reported that there is growing interest in Pro Silva -Close To Nature form of forest management and there is awareness the requirement for integrated forest management for resilience and sustainability.

4. Report of the Treasurer

Anne presented the annual accounts for the 2017 – 2020 period outlining itemised expenditure and revenues for each year. There were deficits in 2017, 2018 and 2019 and a profit in 2020. Anne also presented the balance sheet for each year form 2017 – 2020. Balance at hand at the end of 2020 was €97,612.60.

It was agreed at 2017 AGM that a budget plan was to be provided for following year and agreed at annual meeting. Anne presented details of budget plans that were in place for 2019, 2020, 2021 also giving an actual v plan summary total. Anne presented proposed budget for 2022. Details of accounts and balance sheets are attached as separate report.

As Anne was standing down form the position of treasurer of Pro Silva, Eckart expressed his gratitude to Anne for her great work as treasurer and as liaison re constitution matters with court in Molsheim.

5. Approval of Financial Report and Executive Board

Vote on the Financial Report was approved by 19 -for / 0 against.

Jurij Diaci took control and called for vote on the President for the next three years. Eckart Senitza, Austria was the only person put forward for the position of President - Vote on Eckart Senitza as President of Pro Silva was approved 19/for / 0 against.

6. Election Board of Directors

As there was a change to the constitution Article 5 in the constitution to no longer require for the election of the board of directors at Annual General Meetings this item for the election of directors was not proceeded with.

7. Prolongation and Enlargement of "Pro Silva" Trademark (EU) – Anne Huerzeler

Anne outlined that the Pro Silva trademark presently only covered two classes, field trips and training. The trademark is due for renewal. The proposal was that use of the trademark be expanded to include ecosystem services, services to include the field of ecology and for information in scientific research. The item meeting was being asked to vote on was to agree on renewal and enlargement on the use of the "Pro Silva" trademark. Vote was approved by 18 for / 0 against with one abstention.

1. Minutes of 2019 Annual Board of Directors Meeting in Radlje, Slovenia.

Minutes from 2019 Annual Board of Directors meeting were circulated before meeting – no issues were raised form the minutes of the meeting.

2. Vice Presidents report: Jurij Diaci

Jurij reported on survey and web pool presented at 39th Anniversary Meeting at Radlje and a resultant scientific paper submitted to Forestry Journal "Continuous Cover Forestry in Europe: Extent, Knowledge Gaps and Challenges to Uptake" Mason et al.2021.

Jurij reported on the setting up of an initiative group for Research and Development projects with focus on Pro Silva / Close to Nature Forest Management. The group members are S. Bertin, J. Carvalho, B. Mason, F. Borlea & J. Diaci: Examples of topics to be considered are forest restoration, climate change adaptation, exemplary forests. Projected financial instruments for funding such research could be through COST or Interreg. Group are seeking a person with experience in management of grant application willing person to co-ordinate research projects.

Jurij Diaci and Joao Carvalho made two presentations to EU DG Environmental panel on Biodiversity Strategy. The panel wished to promote a position emulating natural disturbances / Closer To Nature forestry within the strategy. This was a great opportunity for ProSilva in that the PS principles are being recognised and that ProSilva have involvement in the preparation of the new strategy.

Phil Morgan: Phil spoke on fact that more people and organisations are becoming more aware and receptive of Pro Silva ideas and principles. Phil mentioned the requirement to be able to demonstrate the PS principles and practicalities of applying the practices in the forest to a wider audience and that we do have this through the exemplary forests.

As both Phil and Jurij are stepping down from vice-president position Eckart gave special thanks to Jurij and Eckart for their involvement in the Executive Board and service to Pro Silva.

3. Secretary's Report - Padraig O Tuama

Padraig reported that there were 4 meetings in 2019, 2 meetings in 2020 and 4 to date in 2021. Meetings were held roughly every three months, initially through SKYPE conference calls in 2019 and 2020 and through ZOOM calls in 2021.

The items on the agendas for each meeting were very much reflected the agenda for today's meeting. Comprehensive minutes are available for each meeting. Most ongoing communication between the board members is through intense mail exchange.

Padraig notified the member organisations that he will be issuing request for Annual Reports for each country organisation giving list of Contacts – Presidents and Secretaries and activities.

4. Administrators Report -Alex Held

Alex reported on working on the relationship between European Forest Institute (EFI) and Pro Silva. There is more regular exchange and promotion within EFI especially through EFI's INTEGRATE + programme. Pro Silva issued a letter of support the EFI SUPERB project as associate project partner. There is now also a formal arrangement in place for Elisabeth Pötzelsberger, Head of EFI's Resilience programme to meet with ProSilva. Letter has to be answered.

The vary in size from 2.0ha to 17.000ha and are situated in Austria, Belgium, France, Germany, Greece, Hungary, Ireland, Italy, Romania, Czech Republic, Portugal, Slovenia, Slovakia, Switzerland. We are hoping to receive proposals from Croatia, Denmark, Lithuania, Luxembourg, Netherlands, Spain, CCFG.

There is also the possibility of cooperation with AFI network of over 130 Research stands.
